

Veterans Program and Intellectual Point Terms and Conditions

The Veterans Program in which you have chosen to enroll is offered under the direction of the Veterans Administration and was designed to help Veterans get the training they need for technology jobs without consuming their GI Bill[®] benefits. Intellectual Point is an approved training provider, and our objective is to ensure Veteran students complete their course(s), take the appropriate certification exam(s), and go on to achieve Meaningful Employment.

Meaningful Employment may consist of:

- Employment in a career supported by the completed training program.
- · Promotion in the Veteran's current career supported by the completed training program.
- Self-employment, if the Veteran owns or operates a business, that utilizes the skills obtained in the completed training program.

For the Veteran and Intellectual Point to be compliant with the Department of Veterans Affairs requirements, the student agrees to the following:

- 1. Once enrolled, no changes can be made. If a student resigns before completion, the student is financially responsible for the prorated portion of the program they completed.
- 2. The student agrees to a weekly certification prep status review.
- 3. The student agrees to sit for the respective Certification Exam on the final day of the Lab curriculum.
- 4. The student agrees to take the exam remotely, at Intellectual Point or another Authorized Testing Center.
- The student agrees to purchase the exam out of pocket. Certification exams are only eligible for reimbursement through GI Bill[®] It is the student's responsibility to complete and follow the instructions on form VBA-22-0803-ARE and return to the VA for processing.
- 6. The student will obtain Meaningful Employment as defined above within 180 days from the last day of the Program.
- 7. The student agrees to weekly progress reviews with Intellectual Point during the 180 days.
- 8. The student agrees to complete form VBA-22-10201-ARE and return to Intellectual Point along with acknowledgement from the employer once the student has accepted a new position or received recognition of promotion.
- The student acknowledges that failure to complete form VBA-22-10201-ARE and return to Intellectual Point along with acknowledgement from the employer within 180 days from the last day of the program will result in student financial responsibility through an Intellectual Point Demand Letter and notice to the Department of Veterans Affairs.

- 5. Intellectual Point will provide defined career support and services but does not guarantee job placement.
- 6. Intellectual Point reserves the right to reschedule the course or program start date if the student enrollment is not sufficient.
- 7. Intellectual Point reserves the right to terminate a student's training for unsatisfactory progress, nonpayment of tuition or failure to abide by established standards of conduct.
- 8. If a Veteran fails to meet eligibility requirements, the Veteran is eligible to pay out-of-pocket. It is understood however, that the Veteran would be subject to the same financial terms and conditions with the exception of that individual's call to active duty.
